

## **KIDZ SPONSOR PARENTAL AGREEMENT AND PARTICIPATION CONTRACT**

This Parental Agreement and Participation Contract (the "Agreement") is made between Kidz Sponsor, Inc., a nonprofit organization in Arizona, with its principal address office at 9221 E. Baseline Rd., Suite 109-165, Mesa, AZ 85209 ("Kidz Sponsor"), and the undersigned parent(s) or legal guardian(s) ("Parent(s)" or "Guardian(s)") of the minor child (the "Child"). This Agreement outlines the terms and conditions for the Child's participation in the Kidz Sponsor program.

### **Summary of Key Responsibilities**

#### **For Parents/Guardians:**

- Ensure funds provided by Kidz Sponsor are used solely for the Child's combat sports activities.
- Maintain regular communication with Kidz Sponsor.
- Ensure the Child adheres to the program's code of conduct and academic requirements.
- Notify Kidz Sponsor of any extended absences or issues that may affect the Child's participation.

#### **For the Child:**

- Maintain consistent attendance (50% or greater) at training sessions.
- Adhere to the code of conduct, maintaining exemplary behavior.
- Strive for satisfactory academic performance.

### **1. Acknowledgment of Terms and Conditions**

By signing this Agreement, the Parent(s) or Guardian(s) acknowledge and agree to these terms, ensuring the Child follows all rules and guidelines set by Kidz Sponsor. The Child's participation is contingent upon adherence to these terms.

### **2. Mission and Use of Funds**

Kidz Sponsor is dedicated to supporting young athletes in combat sports. The Parent(s) or Guardian(s) agree that Kidz Sponsor has the sole authority to allocate and use all funds, including sponsorship donations, to support its mission.

### **3. Financial Responsibility and Use of Funds**

All funds provided by Kidz Sponsor are donated as sponsorships for the Child's participation in combat sports activities, including training, equipment, and tournament fees. These funds must be used exclusively for the Child's combat sports development within recognized programs such as boxing, jiu jitsu, judo, kickboxing, mixed martial arts, muay thai, taekwondo, or wrestling. Any use outside these categories requires prior approval from Kidz Sponsor.

If there is any misuse of funds, Kidz Sponsor will initiate an investigation, during which the Child's enrollment will be suspended. The Parent(s) or Guardian(s) must provide receipts or invoices for all expenditures. Unused or leftover funds will be managed ethically by Kidz Sponsor as deemed appropriate.

Once the funds in the Child's sponsorship account reach \$50, they will be distributed to the Parent(s) or Guardian(s) on a monthly or bi-monthly basis.

Financial Institution Information: Kidz Sponsor is currently using J.P. Morgan Chase as its financial institution. Chase offers Zelle, which is an easy way to send money. We prefer to use Zelle through Chase. We will also explore enrolling in other peer-to-peer payment options similar to Zelle. However, other services may charge fees, so please take that into account. Kidz Sponsor may also decide to issue a check as well.

### **4. Code of Conduct and Behavioral Standards**

The Parent(s) or Guardian(s) must ensure that the Child maintains exemplary standards of conduct. Examples of acceptable behavior include respect for others, adherence to training rules, and positive engagement in the community. Unacceptable behavior includes any illegal or unethical actions, bullying, or conduct that harms Kidz Sponsor's reputation.

If behavioral issues arise, the Parent(s) or Guardian(s) will be given reasonable time to address them before any disqualification from the program.

### **5. Academic Performance Requirements**

The Child is encouraged to maintain satisfactory academic performance. This requirement is intended to motivate the Child to do well in school. Parents can contact Kidz Sponsor to discuss any academic challenges the Child faces. Kidz Sponsor may, at its discretion, offer support services to help the Child improve.

## **6. Training Commitment and Attendance**

**6.1 Regular Attendance:** The Child must maintain consistent attendance, defined as 50% or greater, at combat sports training sessions. Regular engagement is essential for continued participation.

**6.2 Excused Absences:** Kidz Sponsor understands that illness and family emergencies may occur and will accept excused absences under these circumstances.

**6.3 Extended Absence Notification:** Parent(s) or Guardian(s) must notify Kidz Sponsor of any absence longer than 30 days. Failure to notify may result in termination of the Child's participation.

**6.4 Impact of Absence:** Kidz Sponsor reserves the right to reassess the Child's eligibility for the program in the event of extended absences.

## **7. Termination of Enrollment**

**7.1 Age Limitation and Continuation of Enrollment:** Upon turning 18, the Child must independently contact Kidz Sponsor to continue in the program.

**7.2 Review Process:** Before termination, Kidz Sponsor will conduct a review process, allowing Parent(s) or Guardian(s) to address any concerns.

**7.3 Communication Failure:** If communication cannot be established, Kidz Sponsor may temporarily suspend the Child's enrollment until communication is restored.

**7.4 Termination by Kidz Sponsor:** Kidz Sponsor may terminate this Agreement at its sole discretion, resulting in the forfeiture of all benefits.

## **8. Media Release and Social Media Engagement**

Parent(s) or Guardian(s) may opt out of having the Child's image used publicly on social media platforms. Kidz Sponsor will address any concerns and remove the image if requested. Kidz Sponsor respects the privacy of both the Child and the Parent(s) or Guardian(s) and will take appropriate action to address any media-related concerns.

## **9. Community Engagement**

The Child is encouraged to participate in community outreach activities organized by Kidz Sponsor. Positive contributions may lead to additional recognition.

## **10. Legal Compliance and Dispute Resolution**

All disputes related to this Agreement must go through binding arbitration in Mesa, AZ, Maricopa County. Arbitration is a process where disputes are resolved outside of the court system by a neutral third party. By agreeing to this, Parent(s) or Guardian(s) waive their right to bring claims in a court of law.

## **11. International Participants**

If the Child is enrolling in the Kidz Sponsor program from a country outside the United States, the Parent(s) or Guardian(s) agree that the Child's participation is subject to U.S. laws and the terms of this Agreement. The Parent(s) or Guardian(s) acknowledge and agree that they understand and accept the legal framework of the United States as it applies to this Agreement.

Commitment to International Support: Kidz Sponsor is committed to supporting children in combat sports around the world. While Kidz Sponsor will make every effort to provide financial and programmatic support to international participants, the Parent(s) or Guardian(s) acknowledge that logistical, legal, and financial constraints may impact the level of support provided.

The Parent(s) or Guardian(s) also agree to provide any necessary documentation or information required by Kidz Sponsor to comply with U.S. laws and regulations, including those related to international financial transactions.

## **12. Proof of Expenses and Receipts**

The Parent(s) or Guardian(s) agree to provide proof of expenses, including receipts or invoices, for all expenditures related to the Child's participation in the Kidz Sponsor program upon request. This documentation must be retained and provided to Kidz Sponsor as evidence of the proper use of funds. The Parent(s) or Guardian(s) are responsible for saving all receipts and financial records related to the Child's participation in combat sports and must make these available to Kidz Sponsor upon request.

## **13. Injury Disclaimer and Liability Waiver**

By enrolling the Child in the Kidz Sponsor program, the Parent(s) or Guardian(s) acknowledge and agree that combat sports carry inherent risks, including but not limited to physical injury. The Parent(s) or Guardian(s) understand and accept that Kidz Sponsor, Inc., its directors, officers, employees, agents, volunteers, and affiliates will not be held liable for any injuries, damages, or losses that may occur as a result of the Child's participation in combat sports or any activities related to the Kidz Sponsor program.

Waiver of Liability: The Parent(s) or Guardian(s) hereby release, waive, discharge, and covenant not to sue Kidz Sponsor, Inc., or any of its representatives from any and all liability, claims, demands, actions, and causes of action arising out of or related to any loss, damage, or injury, including death, that may be sustained by the Child while participating in the Kidz Sponsor program, regardless of whether the injury or loss is caused by the negligence of Kidz Sponsor or otherwise.

This waiver and release of liability apply to any and all injuries that may occur during training, competitions, events, travel, or any other activities associated with combat sports.

#### **14. Contact Information and Updates**

Parent(s) or Guardian(s) must maintain up-to-date contact information. Communication may be via phone, email, or the US Postal Service. If communication cannot be established, Kidz Sponsor may temporarily suspend the Child's enrollment until communication is restored. Failure to maintain updated contact information could lead to delays in communication regarding the Child's participation.

#### **15. Contract Revisions and Updates**

Kidz Sponsor reserves the right to revise this Agreement. Parent(s) or Guardian(s) will have 30 days to review and sign any revised contract once communication is acknowledged. Failure to do so may result in the termination of the Child's enrollment.

#### **16. Miscellaneous**

Kidz Sponsor, Inc. is a nonprofit organization incorporated on March 20, 2024. The Parent(s) or Guardian(s) understand that Kidz Sponsor is not liable for changes to sponsorships or future funding.
